Strategic investment is flowing into the Caribbean. Some of Canada’s largest financial institutions (RBC, CIBC and Scotiabank) have invested billions of dollars into the region. The reason these Canadian banks are investing so heavily in the Caribbean is because they see economic growth in the region - the same economic growth that AIC Limited saw when it acquired National Commercial Bank of Jamaica in 2002.
